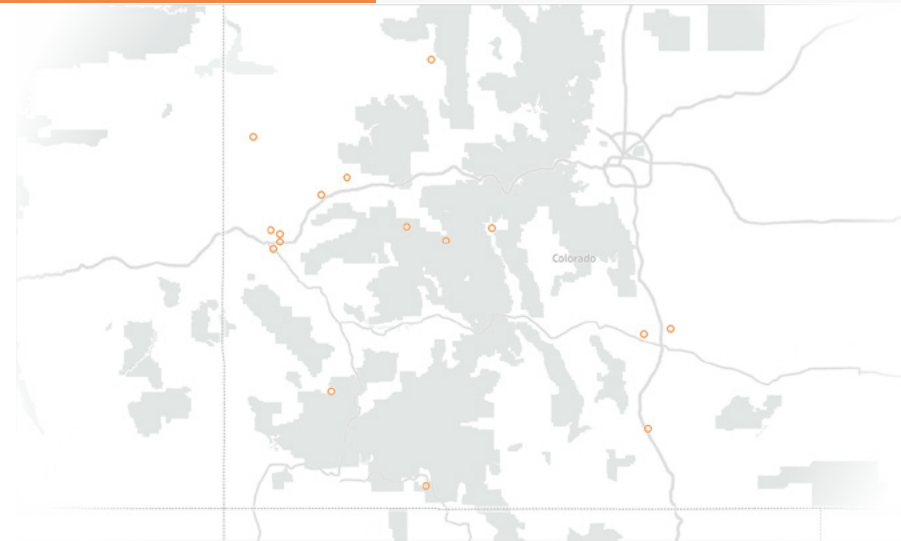
Annual value of goods & services exports to Canada from Colorado's 3rd Congressional District:

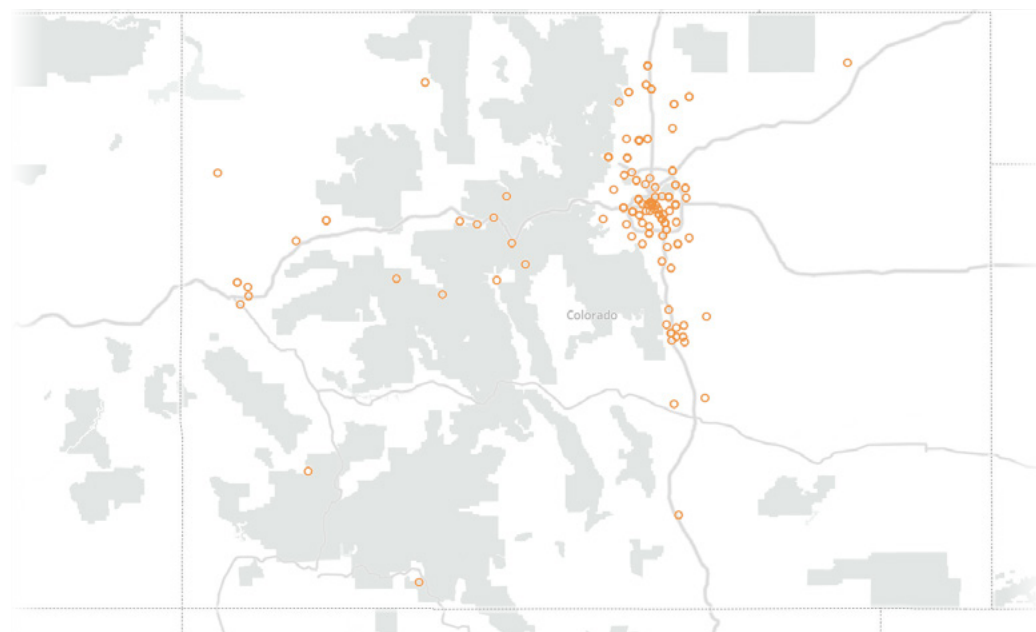
